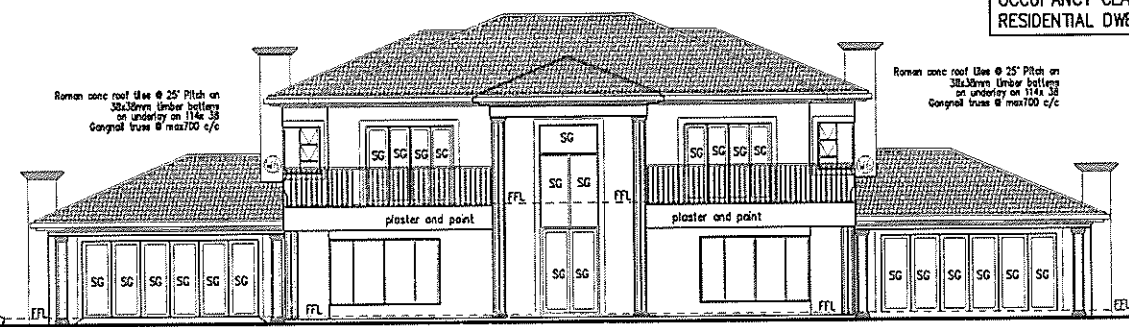

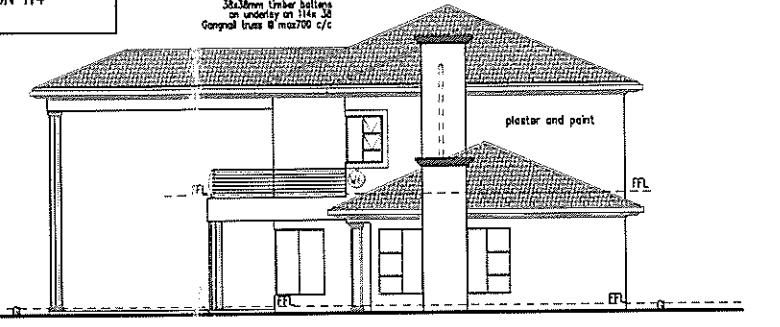
ELEVATION 2 (NORTH WEST)

ELEVATION 1 (SOUTH EAST)



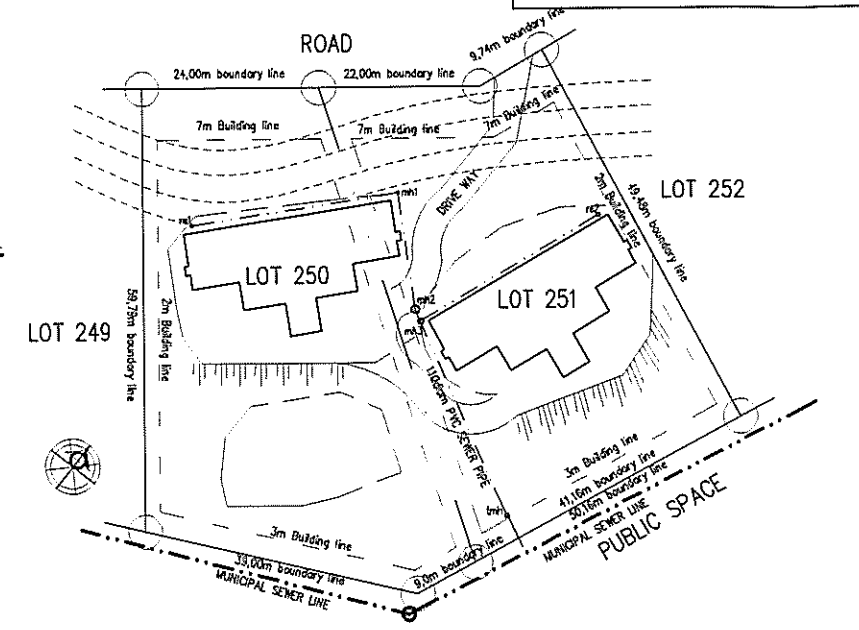
ELEVATION 4 (NORTH EAST)

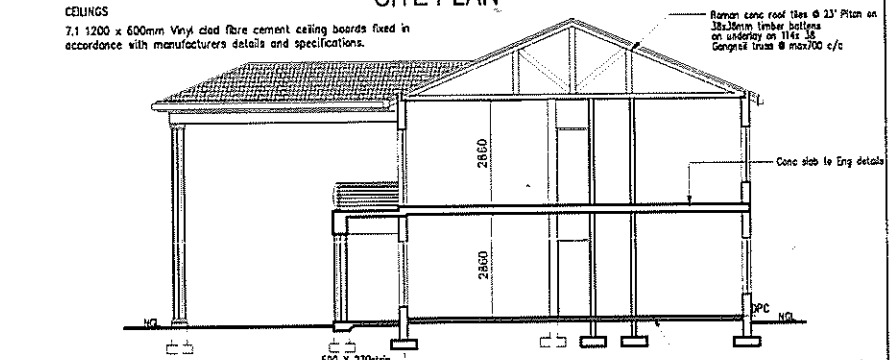

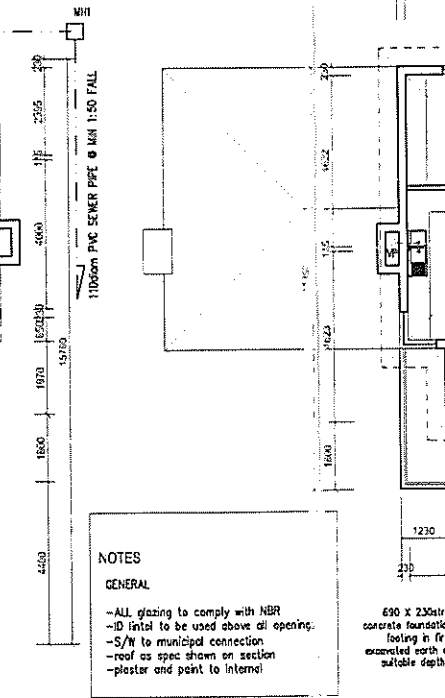
SISALATION

B.3 All glass exceeding 1 Sq.m in area on any door or window and any glass within 300mm of the floor shall be safety glass complying with NBR 9433.

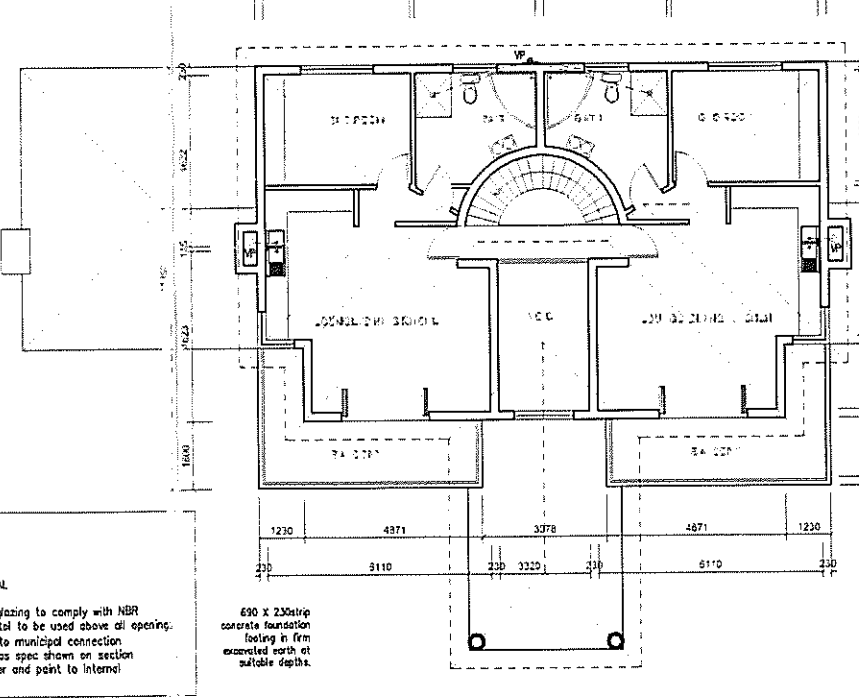


GROUND FLOOR PLAN
