**NOTE 1: SCHEDULE 1 TO ACT 71 OF 1991**

Businesses in respect of which a licence is required.

Item 1: Sale or supply of meals or perishable foodstuffs

(1) The carrying on of business by the sale or supply to consumers of :

- (a) Any foodstuff in the form of meals for consumption on or off the business premises; or
- (b) Any perishable foodstuff

(2 ) For the purpose of sub- item (1) “ perishable foodstuff” means any foodstuff or category of foodstuffs declared by an Administrator by notice in the Gazette to be a perishable foodstuff in the Province concerned for the purposes of this item.

**NOTE 2:**

The administrator of Natal has declared unpreserved –

- (a) Milk
- (b) Meat of all animals and birds; and
- (c) Fish, fish spawn, molluscs and crustaceans

To be perishable foodstuffs for the purpose of this item.

**NOTE 3:**

In terms of regulation 6(2) of the regulations published by the administrator under section 6(1)

(a) of the Act, an application shall be accompanied by –

- (a) The written consent of the landlord, if any ; and
- (b) In the case of an application lodged on behalf of a registered company, the certificate of incorporation of such company; and
- (c) In the case of an application lodged on behalf of a n close corporation, the founding statement of such close corporation; and
- (d) In the case of premises not previously licensed for the type of business intended to be undertaken by the applicant, building plans of such premises to the satisfaction of the licensing authority.
